#### **Keep Your Picnics Safe**

The weather is warming up and that mean it's time for picnics. Picnics are a great way to have fellowship with friends and family the outdoor temperature is over while enjoying delicious food. However, make sure to follow these food safety tips to ensure good memories and not memories of getting a foodborne illness.

Keep cold food cold - Pack cold food in a cooler with ice or gel packs. Remember that cold air travels down, so the ice or gel packs should be placed on top of the food. Raw meat, poultry and seafood should be packed in separate coolers or in containers that will not cause cross contamination in the cooler.

Keep coolers closed – Limit how often you open a cooler. Put drinks in a separate cooler since it will be opened more often than Source: FDA Food Facts - Eating the food cooler.

Follow the 2-hour rule – Hot and cold foods should not set out more than 2 hours or 1 hour if 90°F. Throw it away if left out over 2 hours.

Keep hot foods hot – Hot food should be kept above 140°F. Wrap cooked foods in foil and place in an insulated container until serving.

Don't reuse platters or utensils -Using the same platter or utensils that previously held raw meat allows bacteria from the raw food juices to spread to the cooked food. Have a clean platter and utensils ready for the finished grilled food.

 Registration is currently open for 2023 Junior 4-H
 Camp at Smith Mountain Lake. This year youth from Bath and Highland will attend camp July 10-14 with

campers from Alleghany, Augusta, and Rockingham 4-H. In addition to my work with the other 4-H Agents from our camping group to develop classes and organize lodging and



schedules, I am currently soliciting donations to help with camp scholarships and costs associated with transportation and camp program materials. I have enjoyed getting out into the community and sharing the benefits and impacts of 4-H camp.

 As the school year begins to wind down, Bath and Highland 4-H is planning Cloverbud Day Camps and summer programs to offer to local youth. We are

#### **Invasive Plant Control**

Invasive Plant Control Program - The Highland County Board of Supervisors approved an Invasive Plant Control program for 2023 to help Highland landowners offset the cost of herbicides for invasive plants like multiflora rose, barberry, and autumn olive. The value of the incentive is a set amount for landowners that have at least 50 acres of open land owned or leased with landowner's approval and a minimum of 10 percent infested with one or all of the targeted invasives. Payment incentives are based on a two-tier flat rate process (ex. 50-99 acres and a minimum of 10% treated, the incentive will be a maximum of \$50 or 50% of the cost of the herbicide (whichever is less)). See chart below. Qualified participants will be selected on a first -come, first-served basis. A list of approved herbicides is provided with the sign-up packet. Sign-ups are open through April 21st with receipts due by the end of September. For more information, please call or email the Extension office.

Payment Incentive:

Japanese barberry

- 50-99 acres and a minimum of 10% treated, the incentive will be a maximum of \$50 or 50% of the cost of the herbicide (whichever is less)
- 100-149 acres and a minimum of 10% treated, the Incentive will be a maximum of \$100 or 50% of the cost of the herbicide (whichever is less);
- 150-199 acres and a minimum of 10% treated, the incentive will be a maximum of \$150 or 50% of the cost of the herbicide (whichever is less);
- 200 or more acres with a minimum of 10% treated, the incentive will be a maximum of \$200 or 50% of the cost of the herbicide (whichever is less).

## **Poultry Chain is Underway**

Ag & 4-H partnerships in Extension continue with the 2023 Bath-Highland 4-H Poultry Program. Eleven youth are signed up to participate this year with chicks to arrive May 31st. Youth are raising Black Australorp and Americana breeds during this year's program term.



Chicks come from a certified Avian Influenza-free and Salmonella-free hatchery which is monitored through the voluntary National Poultry Improvement Plan (NPIP). Youth receive 10 chicks and must show and sell five of those chicks to fund next year's poultry chain program. The remaining five chicks they keep can be added to their home flocks for egg or meat purposes or sold as well. Along with raising chicks, youth participate in educational sessions to help them learn about the poultry



industry. A primary focus this year is biosecurity with the presence of avian influenza (AI) in VA commercial and backyard flocks. If you are interested in adding 4-H chickens to your home flock, mark your calendar to attend and BID on at the 2023 Poultry Show and Sale held during the Bath County Fair on September 23<sup>rd</sup> at Millboro Elementary School.
